Manitoba meeting on activity based funding

The Manitoba government recently held a meeting in Winnipeg with researchers and policymakers to begin to explore its options in funding hospitals. Jason Sutherland, the editor of Health Care Funding News, presented on activity-based funding (ABF) as an alternative to the global budgeting program currently in use.

Dr. Sutherland cautioned Manitoba to consider several issues before initiating ABF policy. Access, for example, may be a greater issue under ABF given the rural nature of the province and its sparse population. Price setting using cost data from other provinces may also have unintended consequences to the provision of health care.

Funding policies in post-acute care

The Canadian Health Services Research Foundation released a new paper on funding alternatives and challenges associated with post-acute care. The paper argues that the Canadian post-acute care sector is incredibly fragmented, lacking standardized definitions of care and exhibiting a variety of public and private providers and differing levels of care intensities. This fragmentation, combined with the lack of evidence-based care guidelines, leads to inappropriate utilization of care and backlogs of patients waiting for discharge from acute care facilities (i.e., alternate level of care patients).

Improving the funding system in post-acute care faces considerable challenges, not the least of which is the lack of reliable and timely data. Data are a crucial component of any funding system, not just for evaluation but also for price setting.

Policy options for the financial sustainability of health care systems in Canada and abroad

The Canadian Health Services Research Foundation will host a pre-conference event to the 8th World Congress on Health Economics in Toronto, Ontario on July 10, 2011. Studying activity-based funding in British Columbia

Activity based funding (ABF) initiatives for funding hospital care are growing in popularity across Canada. British Columbia has recently implemented the most ambitious ABF initiative, dedicating \$250 million to increase surgical capacity across the province. A study proposal aimed at investigating the effects of this initiative was recently published in BMC Health Services Research.
